	61% achieved GLD (Good Level Development) in line with last year.			
	• KS1: Reading 85%; Writing: 67%; Maths 81%; Science 78%; No SPAG results			
	due to withdrawal of tests by DfE.			
	KS2: Y2 low cohort and includes 2 children with behaviour issues both			
	physical and verbal abuse. EHC plans declined for these 2 children. AHoS			
	advised a mediation meeting with LA SEN team is planned to discuss support			
	programmes. AHoS will update outcome at future meeting. Parent of one			
	child has refused family support. Their involvement is needed prior to any			
	CAMHs referral. To provide additional classroom support consideration is			
	being given to employing an apprentice TA.			
	• KS2 results overall not as good as KS1. Reading: 47%; Writing: 50%; Maths:			
	61%; SPAG: 50%; Combined 29%. Appealed results of 4 papers all were			
	declined but were only 1 point of achieving expected attainment level.			
	AHoS advised action already being taken both herself and CW are teaching			
	Y6 literacy and maths to avoid any potential dip, still a lot of work to be			
	done. Overall the cohort had had high mobility with only 9 children in			
	school from KS1; 10 SEN children; 1 statemented.			
	PIXEL will continued to be used, staff are aware of issues and the class will be			
	split to help with more tailored differentiation. Staff Governor (CW) advised			
	that PIXEL have now released personal learning for years 3-5 which will help			
	to identify and plug gaps which will hopefully permeate through to Y6. Staff			
	are doing all they can.			
7.	Phonics screening			
	• 73.8% passed phonics test, previous year was 83%.			
	AHoS advised Y1 had had a turbulent year, inconsistent teaching but had			
	managed to plug the gaps.

A concern is that chd don't read at home so school offers reading at breaks/lunchtimes. Also run a homework club. Parents are not engaged with chd's learning even though they sign the home school agreement. Q: Do we need to do a workshop to demonstrate how valuable reading can be? A: AHoS advised sessions have been previously offered but were not well attended. AHoS is looking at sharing such information before social ev	SLT
